

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the Department of Justice, Community
Oriented Policing Services Technology FY2015 budget)**

RESOLUTION NO. 15-223

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Department of Public**
2 **Safety, Community Oriented Police Services (COPS) Technology FY15 budget**
3 **450-15-5004 through Resolution 14-329, in the amount of \$100,000; and**

4 **WHEREAS, the Department of Public Safety is requesting a budget amendment to add line**
5 **item 7500 Major Capital to the FY15 budget; and**

6 **WHEREAS, there will be no change to the total budget amount; and**

7 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**
8 **Council have reviewed this Budget Amendment and recommend its approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
10 **approves the Amendment No. 1 for the Department of Justice, Community**
11 **Oriented Policing Services Technology FY 2015 budget and with no change to the**
12 **overall budget amount.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **Chairperson and any designated official to expend and administer the Budget,**
15 **as attached, provided that any amendments affecting the funds or funding level**
16 **is submitted for further prior approval by the Tohono O'odham Legislative**
17 **Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
19 **day of JUNE, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**




