

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adjusting Apportionment of Tohono O'odham Legislative Council Votes in Accordance with
Election Board's Certification of District Votes)

LEGISLATIVE ORDER NO. 15-224

1 **WHEREAS, Article V, Section 2 of the Constitution of the Tohono O'odham Nation provides**
2 **that votes cast by Legislative Council representatives shall be apportioned as**
3 **follows:**

4 **Each district shall be entitled to as many votes on the Tohono**
5 **O'odham Council (divided by ten) as there are members of the**
6 **Tohono O'odham Nation residing in the district. Such votes may**
7 **be cast by either or both of the district representatives, or their**
8 **alternates, who are present and voting.**

9 **; and**

10 **WHEREAS, on May 23, 2015 the Tohono O'odham Election Board conducted a general**
11 **election for the offices of chairperson of the Nation, vice-chairperson of the**
12 **Nation, and representatives and alternates to the Tohono O'odham Legislative**
13 **Council and district councils; and**

14 **WHEREAS, on May 23, 2015 the Election Board issued its Certificates of Election Results in**
15 **accordance with 12 T.O.C. Chapter 1 - Elections Section 1806(J); and**

16 **WHEREAS, the Election Board certified and posted its Certification of District Residents,**
17 **entitled "Certification of District Votes," dated May 23, 2015, which is**
18 **incorporated by this reference, apportioning the number of votes each district**
19 **is entitled to cast on the Tohono O'odham Legislative Council (Elections, Section**
20 **1801(B)); and**

21 **WHEREAS, the number of Legislative Council votes apportioned and certified by the**
22 **Election Board in its "Certification of District Votes" totals 3015.3; and**

23 **WHEREAS, the five-day period for appealing the number of votes given to each district by**
24 **the Election Board has expired and no such appeal has been filed.**

25 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council accepts the**
26 **apportionment of votes each district is entitled to cast on the Tohono O'odham**
27 **Legislative Council in accordance with the Election Board's "Certification of**
28 **District Votes" dated May 23, 2015 and directs the Legislative Council secretary**
29 **to adjust Legislative Council votes accordingly effective upon the Council's**
30 **issuance of certificates of election pursuant to Section 1808 of 12 T.O.C. Chapter**
31 **1 - Elections.**

7 **16 of the Act of June 18, 1934 (48 Stat.984).**
