1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
11 **approving applicants for membership contain misspellings in the names of**
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 15-82, 83-**
14 **83, 69-88, 97-322, 97-350, 98-034, 98-083, 98-123, 98-174, 99-080, 99-311, 99-360,**
15 **99-475, 99-633, 2000-035, 03-193, 04-291, 06-511, 15-076 and 08-035 be amended**
16 **to reflect the correct name spelling and/or roll numbers for the individuals**
17 **identified in the Amending Enrollment Resolution List June 2015, which is**
18 **incorporated by this reference.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
20 **Resolution Nos. 15-82, 83-83, 69-88, 97-322, 97-350, 98-034, 98-083, 98-123, 98-**
21 **174, 99-080, 99-311, 99-360, 99-475, 99-633, 2000-035, 03-193, 04-291, 06-511, 15-**
22 **076 and 08-035 are amended upon the effective date of those resolutions to**
23 **reflect the corrected names or roll numbers identified in the Amending**
24 **Enrollment Resolution List June 2015.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
26 **day of JUNE, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
