12		income; and
13	WHEREAS,	the District identified the need to increase the Information Technology (I.T.)
14		department budget to purchase equipment, install and maintain internet
15		service to the Education Building, thereby increasing the I.T. department
16		budget to \$392,398.36; and
17	WHEREAS,	the savings from capital equipment purchase from Garage/Van Pool (G/V Pool)
18		department will cover the additional I.T. costs, thus reducing, the G/V Pool
19		departmental budget to \$435,370.24; and
20	WHEREAS,	Amendment No. 01 increases the FY 2015 Deficit of Expenses from \$1,165,289.84
21		to \$1,396,111.24; and
22	WHEREAS,	the District Council intends to utilize FY 2015 budget savings, gaming revenues
23		and investment funds to meet the projected amount outlined in the attached FY
24		2015 budget worksheet; and
25	WHEREAS,	Amendment No. 01 was reviewed by the Budget and Finance Committee on May
26		21, 2015.
