

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and authorizing an appropriation and allocating general fund surplus**  
**for FY 2015 Florence KOHF-LP Radio Project budget)**

RESOLUTION NO. 15-237

1 **WHEREAS, on March 10, 2014 the Nation received from the Federal Communications**  
2 **Commission (FCC) a construction permit to proceed with a low power FM radio**  
3 **station for the community of Florence; and**

4 **WHEREAS, the construction permit is scheduled to expire on September 10, 2015; and**

5 **WHEREAS, Hewel Ni'ok management has prepared the attached budget which provides**  
6 **funds for the purchase of equipment and construction of the Florence low power**  
7 **FM radio station; and**

8 **WHEREAS, the Cultural Preservation and Budget and Finance Committees of the Legislative**  
9 **Council has reviewed this budget and recommends its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
11 **approves and authorizes an appropriation from the general fund surplus for FY**  
12 **2015 Florence KOHF-LP Radio Project in the amount of \$80,695.57 as presented**  
13 **in the attached budget, which is approved.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Chairman and any designated official to expend and administer the budget as**  
16 **attached, provided that any amendments affecting the funds or funding level is**  
17 **submitted for further prior approval by the Tohono O'odham Legislative**  
18 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
20 **day of JUNE, 2015 at a meeting at which a quorum was present with a vote of 2,720.4 FOR; 294.9**  
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
25 **June 18, 1934 (48 Stat.984).**


