8		attached budget; and
9	WHEREAS,	the Election Board is requesting these funds be appropriated from General
10		Fund Surplus; and
11	WHEREAS,	the Rules and the Budget and Finance Committees of the Legislative Council
12		have reviewed this Budget amendment #1 and recommend its approval.
