

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2015 Budget Amendment #2 for Rodeo and Fair)**

**RESOLUTION NO. 15-239**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2015 Budget for the**  
2 **Rodeo and Fair by resolution #14-353 and #14-371; and**

3 **WHEREAS, by resolution #14-547 approved the Rodeo and Fair FY2015 Budget Amendment**  
4 **#1; and**

5 **WHEREAS, the Rodeo and Fair Budget Amendment #2 increases the budget in the amount of**  
6 **\$72,816.02 from proceed received from program revenue, sponsorship and**  
7 **contributions solicited to support the rodeo and fair event; and**

8 **WHEREAS, the budget amendment #2 increases operational line items; and**

9 **WHEREAS, the FY 2015 Rodeo and Fair Budget Amendment #2 has been reviewed by the**  
10 **Agricultural and Natural Resources and the Budget and Finance Committees of**  
11 **the Legislative Council and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
13 **approves the Rodeo and Fair Budget Amendment #2 to:**

14 **1. increase operational line items in the amount of \$72,816.02 from revenue**  
15 **received from program revenue, sponsorship and contributions to**  
16 **support the annual rodeo and fair event.**

17 **2. Increase the budget from \$329,591.27 to \$402,407.29.**


18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the budget,**  
20 **as attached, provided that any amendments affecting the funds or funding**  
21 **levels of the budget shall be submitted for further prior approval by the Tohono**  
22 **O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
24 **day of JUNE, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**


