

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Holding June 19, 2015 General Session at San Xavier Health Center)

LEGISLATIVE ORDER NO. 15-243

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures**
2 **to regulate all meetings of the Tohono O'odham Council, standing committees,**
3 **boards and special committees." (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative**
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be**
7 **held at the Tohono O'odham Legislative Council chambers located in Sells,**
8 **Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the**
9 **legislative representatives may vote to hold a session in some location other**
10 **than the chambers located at Sells"; and**

11 **WHEREAS, the Health and Human Services Committee has requested the Legislative**
12 **Council hold its June 19, 2015 general session at San Xavier Health Center**
13 **beginning at 9:30 a.m.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the June**
15 **19, 2015 general session shall be held at San Xavier Health Center beginning at**
16 **9:30 a.m.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH day of**
18 **JUNE, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
20 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
