

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY 2015 Budget Amendment No. 5)**

1 **WHEREAS, the Chukut Kuk District Council did meet on June 15, 2015 in Miguel Community**
2 **which a quorum was present; and**

3 **WHEREAS, the Chukut Kuk District Council did review and approve Chukut Kuk District FY**
4 **2015 Budget Amendment No. 5 by District Resolution No. 2015-42, Ston Sudagi**
5 **Community FY 2015 Budget Amendment No. 2 by District Resolution No. 2015-41**
6 **and West Villages FY 2015 Budget Amendment No. 2 by District Resolution No.**
7 **2015-40; and,**

8 **WHEREAS, Chukut Kuk District FY 2015 Budget Amendment No. 5 was reviewed by the**
9 **Tohono O'odham Legislative Council Budget and Finance Committee and**
10 **recommends its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **approves Chukut Kuk District FY 2015 Budget Amendment No. 5.**

13 **BE IT FURTHER RESOLVED that Investment Savings in the amount of \$73,500.00 will be added**
14 **to various line items in the Chukut Kuk District Administration budget to cover**
15 **over expenditures and anticipated costs for FY 2015 increasing the FY 2015**
16 **budget from \$1,978,935.31 to \$2,052,435.31.**

17 **BE IT FURTHER RESOLVED that Ston Sudagi Community FY 2015 Budget Amendment No. 2**
18 **incorporated herein is transferring \$1,798.54 from various line items and added**
19 **to line item 865-Other Emergency.**

20 **BE IT FURTHER RESOLVED that West Villages FY 2015 Budget Amendment No. 2 incorporated**
21 **herein is transferring \$1,383.34 to item 850-Food to cover anticipated costs and**
22 **amending justification to line item 892-Non Major Equipment to insert the word**
23 **"twice".**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **District Chairperson and any designated official to expend and administer the**
26 **budget as attached provided that any amendments/modifications affecting the**
27 **funds or funding level of the Chukut Kuk District FY 2015 budget shall be**
28 **submitted to the Tohono O'odham Legislative Council for prior approval.**






