

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2015 Human Resources Office Budget Amendment #2)**

**RESOLUTION NO. 15-247**

1 **WHEREAS, the Human Resources Office provides general support services for the Executive**  
2 **Branch, Legislative Branch, Judicial Branch, the Districts, and two entities of the**  
3 **Nation; and**

4 **WHEREAS, the Human Resources budget was approved by Resolution No. 14-353 and**  
5 **further amended through Resolution No. 15-093; and**

6 **WHEREAS, the Human Resources Office has prepared Budget Amendment #2 to adjust**  
7 **operational line items for the remainder of the fiscal year and to revise the**  
8 **Narrative for Major Capital; and**

9 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
10 **the Legislative Council have reviewed this Budget Amendment #2 and**  
11 **recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
13 **approves the FY 2015 Human Resources Office Budget Amendment #2 as**  
14 **attached with no change to the total original allocation.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the Budget as**  
17 **attached, provided that any Amendments affecting the funds or funding level is**  
18 **submitted for further prior approval by the Tohono O'odham Legislative**  
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 6<sup>TH</sup>**  
21 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
24 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
26 **June 18, 1934 (48 Stat.984).**
