Names of Enrollment Applicants and/or Roll Numbers)**

**RESOLUTION NO. 15-248**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 96-547, 97-**  
14 **322, 98-083, 98-123, 98-357, 99-039, 99-080, 99-360, 02-569, 05-711, 07-112, 15-116,**  
15 **and 2000-397 be amended to reflect the correct name spelling and/or roll**  
16 **numbers for the individuals identified in the Amending Enrollment Resolution**  
17 **List July 2015, which is incorporated by this reference.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
19 **Resolution Nos. 96-547, 97-322, 98-083, 98-123, 98-357, 99-039, 99-080, 99-360, 02-**  
20 **569, 05-711, 07-112, 15-116, and 2000-397 are amended upon the effective date of**  
21 **those resolutions to reflect the corrected names or roll numbers identified in**  
22 **the Amending Enrollment Resolution List July 2015.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 6<sup>TH</sup>**  
24 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
27 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
28 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
29 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**






