(Approving the Department of Health and Human Services, Division of Family
Assistance – FY2015 Tribal Food Distribution Program Budget
Amendment #1 Acct. No. 001-15-6330)**

RESOLUTION NO. 15-251

1 **WHEREAS, by Resolution Number 14-353 the Tohono O'odham Legislative Council approved**
2 **the FY2015 Food Distribution Program Tribal budget in the amount of**
3 **\$223,343.00; and**

4 **WHEREAS, the Nation was notified of the final grant award for the Food Distribution**
5 **Program USDA budget with a decrease in funding, which funding requirement**
6 **is at a 75% match by USDA and a 25% match by Tribal funds; and**

7 **WHEREAS, the Department of Health and Human Services, Family Assistance Division has**
8 **prepared the attached Tribal Food Distribution Program Budget Amendment #1**
9 **which decreases and increases several line items as well as creates new line**
10 **items for 6520 Per Diem; 6530 Transportation; 6540 Mileage POV; 7000 Supplies**
11 **Office; 7005 Supplies Office Equipment; 7100 Utilities; 7110 Communications**
12 **and 7420 R/M Building; and**

13 **WHEREAS, the FY15 Tribal Food Distribution budget amount has increased from**
14 **\$223,343.00 to \$251,928.00; an increase of \$28,585.00; and**

15 **WHEREAS, the Health and Human Services and the Budget and Finance committees have**
16 **reviewed this Budget Amendment #1 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
18 **approve the FY 2015 Tribal Food Distribution Program Budget Amendment #1 as**
19 **attached.**

20 **BE IT FURTHER RESOLVED that Amendment #1 will increase the budget from \$223,343.00 to**
21 **\$251,928.00; an increase of \$28,585.00 to be appropriated from the General Fund**
22 **Surplus.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level**
26 **shall be submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**




