RESOLUTION NO. 15-252

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2015 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution Number 14-361, the Tohono O'odham Legislative Council**
5 **approved the FY2015 Food Distribution Program budget in the amount of**
6 **\$258,186.00, and**

7 **WHEREAS, the Tohono O'odham Nation was notified of the final grant award for the FY2015**
8 **USDA Food Distribution Program budget in the amount of \$244,714.00 a**
9 **decrease of \$13,472.00; and**

10 **WHEREAS, the Department of Health and Human Services, Family Assistance Division has**
11 **prepared the attached FY2015 USDA Food Distribution Program Budget**
12 **Amendment #1 which decreases and increases several line items as well as adds**
13 **new line items for 7100 Utilities and 7110 Communication Expense; and**

14 **WHEREAS, the Health and Human Services and the Budget and Finance committees have**
15 **reviewed this Budget Amendment #1 and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **approves the Department of Health and Human Services, Division of Family**
18 **Assistance – FY2015 USDA Food Distribution Program Budget Amendment #1 as**
19 **attached.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level**
23 **shall be submitted for further prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
26 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**
