RESOLUTION NO. 15-258

1 **WHEREAS, the Tohono O'odham Nation recognizes and prioritizes the importance of**
2 **health, education and general wellbeing for the children of the Nation; and**

3 **WHEREAS, the First Things First initiative was passed by Arizona Voters in 2006 via**
4 **proposition 203 which increases the quality and access to early childhood**
5 **programs that will ensure all Arizona children enter school healthy and ready to**
6 **learn; and**

7 **WHEREAS, the Tohono O'odham Nation operates First Things First Program for children 0-5**
8 **years of age, which provides a support system to families experiencing**
9 **difficulties accessing the family support system; and**

10 **WHEREAS, the First Things First agreement stipulates the grantee may allocate up to 10% of**
11 **the direct cost for indirect cost; and**

12 **WHEREAS, the Health & Human Services and the Budget and Finance Committees of the**
13 **Legislative Council have reviewed the FY 2016 First Things First**
14 **Intergovernmental Agreement (IGA) GRA-RC026-16-0771-01 between the Tohono**
15 **O'odham Nation Regional Partnership Council, Arizona Early Childhood**
16 **Development and Health Board and the Tohono O'odham Nation and**
17 **recommend its approval and adoption.**

18 **NOW THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves:**

9 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
11 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
12 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
14 **June 18, 1934 (48 Stat.984).**


