

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2015 Baboquivari District - Artesia/Little Tucson Community**  
**Budget Amendment No. 1 and the Artesia/Little Tucson Community**  
**"FY 2015-2017 Community Building Project Budget")**

**RESOLUTION NO. 15-260**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation... and to appropriate these funds for the**  
3 **benefit of the Nation and its members" provided that "all expenditures of these**  
4 **funds shall be pursuant to appropriations or budget" authorized by resolution**  
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Sections 1**  
6 **(d)(2); and**

7 **WHEREAS, funds allocated to the Nation's districts may only be expended "pursuant to**  
8 **budgets authorized under resolutions of the district council and approved by**  
9 **the Tohono O'odham Council" (Constitution, Article IX, Section 7); and**

10 **WHEREAS, the Tohono O'odham Legislative Council by Resolution 2015-B-57 authorized the**  
11 **Artesia/Little Tucson Community FY 2015 Budget Amendment No. 1, which is**  
12 **incorporated by this reference, to include FY 2012 Artesia/Little Tucson**  
13 **Community Budget carryover savings in the amount of \$51,493.37, to increase**  
14 **Personnel and Operational line items, and to decrease the Construction line**  
15 **item by \$99,125.00; and**

16 **WHEREAS, the Amendment No. 1 will decrease the overall FY 2015 Baboquivari District -**  
17 **Artesia/Little Tucson Community Budget from \$235,535.54 to a revised total**  
18 **amount of \$187,903.91; and**

19 **WHEREAS, the Baboquivari District Council by Resolution No. 2015-B-58 also authorized**  
20 **the Artesia/Little Tucson Community's request for a new, standalone FY 2015-**  
21 **2017 Community Building Project Budget in the amount of \$99,125.00, which**  
22 **would be transferred from the Community's FY 2015 Construction line item to**  
23 **fund the Community Building Project Budget; and**

24 **WHEREAS, Artesia/Little Tucson Community FY 2015-2017 Community Building Project**  
25 **Budget" be designed for the sole purpose of preparation, construction,**  
26 **completion and furnishing the community building for a two year-project**

1 **WHEREAS, the Budget and Finance Committee of the Tohono O’odham Legislative Council**  
2 **has reviewed the Artesia/Little Tucson Community budget amendment and new**  
3 **budget and recommends approval.**


4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council approves**  
5 **the FY 2015 Baboquivari District – Artesia/Little Tucson Community Budget**  
6 **Amendment No. 1, including FY 2012 carryover savings in the amount of**  
7 **\$51,493.37, for a total revised budget of \$187,903.91 for Artesia/Little Tucson**  
8 **Community and an overall revised budget amount of \$2,094,601.93 for the FY**  
9 **2015 Baboquivari District Budget.**

10 **BE IT FURTHER RESOLVED that the Tohono O’odham Legislative Council approves the**  
11 **Artesia/Little Tucson Community FY 2015-2017 Community Building Project**  
12 **budget in the amount of \$99,125.00 for the sole purpose of preparation,**  
13 **construction, completion and furnishing the community building, and the**  
14 **Budget shall be effective upon the enactment of this resolution until September**  
15 **30, 2017.**

16 **BE IT FINALLY RESOLVED that the Tohono O’odham Legislative Council authorized the District**  
17 **chairperson and any designated official to expend and administer the budgets**  
18 **as attached, provided that any modifications/amendments affecting the funds**  
19 **or funding levels shall be submitted for prior approval by the Tohono O’odham**  
20 **Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 09<sup>TH</sup>**  
22 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article VI, Section 1(d)(2) and Article IX Section 7 of the Constitution of the Tohono O’odham**  
25 **Nation, adopted by the Tohono O’odham Nation on January 18, 1986; and approved by the**  
26 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
27 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
