

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Baboquivari District Administration FY 2015 Budget Amendment #2)**

**RESOLUTION NO. 15-261**

1 **WHEREAS, Baboquivari District Administration presented their FY 2015 Budget**  
2 **Amendment #2 in the amount of \$10,000.00(as attached); and**

3 **WHEREAS, this Amendment #2 will add language to line item 7355 Professional Services**  
4 **“For direct services provided by a professional person (s) and/ or organization**  
5 **delivered under written contract or written agreement”. Also to include the**  
6 **purchase of all material and items needed to complete the projects; and**

7 **WHEREAS, the FY 2015 Budget Amendment #2 will not affect Baboquivari District**  
8 **Administration’s FY 2015 current budget amount of \$619,895.32, nor the overall**  
9 **Baboquivari District’s FY 2015 current Budget of \$2,094,601.93; and**

10 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**  
11 **attached Budget and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby**  
13 **approves Baboquivari District Administration FY 2015 Budget Amendment #2 to**  
14 **add additional language to Line Item 7355 Professional Services.**

15 **BE IT FURTHER RESOLVED that the amendment #2 will not affect Baboquivari District**  
16 **Administration’s FY 2015 current budget amount \$619,895.32, nor will it affect**  
17 **the overall Baboquivari District’s FY 2015 budget in the amount of \$2,094,601.93.**

18 **BE IT FINALLY RESOLVED that the Tohono O’odham Legislative Council hereby authorizes the**  
19 **District Chairperson and any designated official to expend and administer the**  
20 **Budget as attached, provided that any Modifications/Amendments affecting the**  
21 **funds or funding level is submitted for further prior approval by the Tohono**  
22 **O’odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 09<sup>TH</sup>**  
24 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O’odham Nation, adopted by the**  
27 **Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**


