

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Choulic Community FY 2015 Amendment #1)**

**RESOLUTION NO. 15-262**

1 **WHEREAS, Baboquivari District Administration presented FY 2015 Amendment #1 for**  
2 **Choulic Community (as attached); and**

3 **WHEREAS, Choulic Community's FY 2015 Budget Amendment #1 would add language in**  
4 **Occasional Appointment, Lease & Rental and Clothing Allowance line items; and**

5 **WHEREAS, the FY 2015 Budget Amendment #1 will not affect Choulic Community's FY 2015**  
6 **current budget of \$235,535.54, nor the overall Baboquivari District's FY 2015**  
7 **Budget of \$2,094,601.93; and**

8 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**  
9 **attached Budget and recommend its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
11 **approves Choulic Community FY 2015 Budget Amendment #1 to add language in**  
12 **Occasional Appointments, Lease & Rental, and Clothing Allowance line items.**

13 **BE IT FURTHER RESOLVED that the Amendment #1 will not affect Choulic Community's FY**  
14 **2015 current budget amount of \$235,535.54, nor will it affect the overall**  
15 **Baboquivari District's FY 2015 budget in the amount of \$2,094,601.93.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **District Chairperson and any designated official to expend and administer the**  
18 **Budget as attached, provided that any Modifications/Amendments affecting the**  
19 **funds or funding level is submitted for further prior approval by the Tohono**  
20 **O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
22 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
27 **June 18, 1934 (48 Stat.984).**
