**RESOLUTION NO. 15-264**

1 **WHEREAS, the Tohono O'odham Legislative Council approved FY 2015 Judicial Branch**  
2 **Budget Resolution No. 14-347 at \$6,412,715.55; and**

3 **WHEREAS, under Personnel, Amendment #2 decreases line item 6000 Salaries and**  
4 **increases line item 6020 Overtime Wages; and**

5 **WHEREAS, the Judicial Branch has prepared the attached Budget Amendment #2 to reflect**  
6 **the changes listed above; and**

7 **WHEREAS, this Amendment does not increase the total budget amount; and**


8 **WHEREAS, the Legislative Judiciary and the Budget and Finance Committees have reviewed**  
9 **this budget and recommend its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves**  
11 **the attached FY 2015 Budget Amendment #2 for the Tohono O'odham Judicial**  
12 **Branch.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
14 **Chief Judge and any designated official to expend and administer the budget as**  
15 **attached, provided that any amendments affecting the funds or funding level**  
16 **shall be submitted for further prior approval by the Tohono O'odham**  
17 **Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
19 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015,3 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
24 **June 18, 1934 (48 Stat.984).**
