

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving amendment no. 2 to the FY 2015 Bureau of Indian Affairs Law
Enforcement P.L. 93-638 budget)

RESOLUTION NO. 15-265

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**
2 **Corrections Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the FY 2015 638 Law Enforcement budget was approved by Tohono O'odham**
4 **Legislative Council through Resolution no. 14-348; and**

5 **WHEREAS, the Tohono O'odham Nation Police Department is amending its budget to**
6 **include benefits cost not covered under the High Intensity Drug Trafficking Area**
7 **(HIDTA) grant; and**

8 **WHEREAS, amendment no. 2 allows for increases to personnel line items and increasing**
9 **line item 7000 Supplies Office and decrease of Operational Cost; and**

10 **WHEREAS, this amendment increases the Indirect Cost and changes the bottom line**
11 **amount; and**

12 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**
13 **Council have reviewed this budget and recommends its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
15 **approves Budget amendment no. 2 for the 638 Law Enforcement FY 2015 budget**
16 **with an increase to Personnel Expense and a decrease to Operational Expense to**
17 **cover the Benefits not covered by the High Intensity Drug Trafficking Area**
18 **(HIDTA) grant with increase to Indirect Cost and increase to budget amount to**
19 **\$7,273,434.81.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
21 **the Chairman and any designated official to expend and administer the budget**
22 **as attached, provided that any amendments affecting the funds or funding level**
23 **shall be submitted for further prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
26 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)and(f) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**
