

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting July 30, 2015 Special Session for a Election Issues Update and Public Forum)**

LEGISLATIVE ORDER NO. 15-267

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees.” (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1 (a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**
6 **Council with the authority to “by majority vote, call for a special session.”**
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**
8 **1.D.1.); and**

9 **WHEREAS, numerous voters have expressed concern over the conduct of the Nation's 2015**
10 **general election, and the Rules Committee has therefore requested a July 30,**
11 **2015 special session for an election issues update and a public forum to address**
12 **election issues .**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
14 **July 30, 2015 special session for an election issues update from the Rules**
15 **Committee and Election Board and to provide the public with an opportunity to**
16 **voice any concerns over election issues.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09TH day of**
18 **JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
20 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
