

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Special Diabetes Program for Indians (SDPI) Healthy O'odham  
Promotion Program (HOPP) FY 2015 Budget Amendment #2)**

**RESOLUTION NO. 15-268**

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Program for Indians**  
2 **(SDPI) grant funded by the Indian Health Service, Division of Diabetes**  
3 **Treatment and Prevention through September 30, 2015; and**

4 **WHEREAS, the Healthy O'odham Promotion Program has prepared budget amendment No.**  
5 **2 to increase \$2,758.00 in 6130 Unemployment Expense and increase \$5,000.00**  
6 **in 7410 RM Vehicles line items as the current annual allocation has been**  
7 **exhausted; and**

8 **WHEREAS, line item 7420 RM Buildings has been decreased \$7,758.00 to offset the**  
9 **increased amounts; and**

10 **WHEREAS, the Health and Human Service and the Budget and Finance Committees of the**  
11 **Legislative Council have reviewed this budget and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the Special Diabetes Program for Indians (SDPI) Healthy O'odham**  
14 **Promotion Program (HOPP) FY 2015 Budget Amendment #2 and authorizes**  
15 **expenditures to utilize the Nation's resources pending reimbursement from the**  
16 **Grantor for the continuation of this grant:**

- 17 **1. Approve increase to 6130 Unemployment Expense and 7410 RM Vehicles**  
18 **expense line items.**
- 19 **2. Approve decrease to 7420 RM Buildings.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council that it hereby**  
21 **authorizes the Chairman and any designated official to expand and administer**  
22 **the budget, as attached, provided that any amendments affecting the funds or**  
23 **funding level shall be submitted for further prior approval by the Tohono**  
24 **O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
26 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 2,795.3 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and 220 [04] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat.984).**






