

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2015 Department of Health & Human Services – Management
of Health – MOH Amendment #1 Budget)

RESOLUTION NO. 15-269

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Indian Health Service; and**

3 **WHEREAS, the Legislature Council has approved and accepted by Resolution # 14-349, the**
4 **FY 2015 TODHHS/IHS budgets to be effective October 1, 2014 through September**
5 **30, 2015; and**

6 **WHEREAS, Management of Health (MOH) was notified of additional funding from Indian**
7 **Health Service Tucson Area Office tribal shares allocation of \$259,031.00 to be**
8 **added to the FY 2015 budget; and**

9 **WHEREAS, an amendment has been prepared and submitted for approval that will allow**
10 **the change to correct the Office Manager, Senior position to Office Manager**
11 **decreasing the Personnel Expense line items in the amount of \$13,484.82; and**

12 **WHEREAS, also creating new line items 6500 Training and Registration, 7430 RM Grounds**
13 **and 8010 Architectural Design and increasing various operational expenses and**
14 **capital expense line item and increasing Indirect Cost amount and total budget**
15 **amount from \$1,075,348.56 to \$1,354,451.98; and**

16 **WHEREAS, the Health and Human Service and the Budget and Finance Committees of the**
17 **Legislative Council have reviewed this budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves the Management of Health (MOH) attached budget amendment #1:**

- 20 **1. Approve the Indian Health Service Tucson Area Tribal Shares allocation in**
21 **the amount of \$259,031.00.**
- 22 **2. Approve to correct the Office Manager position decreasing the Personnel**
23 **Expense line items.**
- 24 **3. Approve the creating of new Operational Expense line items as well as**
25 **increasing of Operational and Capital Expense line items.**
- 26 **4. Approve the increasing of the Indirect Cost to \$172,346.27 and increasing the**
27 **budget amount to \$1,354,451.98.**

8 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
9 **Article VI, Section 1(d)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
10 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
11 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
12 **the Act of June 18, 1934 (48 Stat.984).**
