1 **WHEREAS, the Tohono O'odham Nation Police Department has negotiated an Agreement**
2 **with the City of Tucson, High Intensity Drug Trafficking Area (HIDTA), Agreement**
3 **no. HT-15-2518; and**

4 **WHEREAS, this Agreement will be used for the Native American Targeted Investigations of**
5 **Violent Enterprises Task Force (NATIVE); and**

6 **WHEREAS, the Agreement will commence on January 1, 2015 and terminate on December**
7 **31, 2016; and**

8 **WHEREAS, this grant only allows for Overtime Cost with no benefits; and**

9 **WHEREAS, the benefits not covered by the grant will be covered by the FY 2015 P.L. 96-638**
10 **Law Enforcement budget amendment no. 2; and**

11 **WHEREAS, the Tohono O'odham Nation Police Department has created an FY 2015 budget**
12 **for the HIDTA grant; and**

13 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees have reviewed the**
14 **Agreement and FY 2015 budget and recommend its approval by the Tohono**
15 **O'odham Legislative Council.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
17 **accepts the Agreement between the Tohono O'odham Nation and the City of**
18 **Tucson High Intensity Drug Trafficking Area (HIDTA), Agreement no. HT-15-**
19 **2518, substantially in the form attached hereto and approves the FY 2015 budget**
20 **for the HIDTA grant with effective dates of January 1, 2015 thru December 31,**
21 **2016 with benefits not allowed by grant to be cost shared under the FY 2015 P.L.**
22 **93-638 Law Enforcement budget amendment no. 2.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
24 **the Chairman to negotiate and execute the Agreement attached hereto,**
25 **provided that any amendments shall be submitted for full approval by the**
26 **Tohono O'odham Legislative Council.**
