

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the FY 2015 Child/Adult Food Program Budget Amendment #1 to  
Include FY 2014 Savings)**

**RESOLUTION NO. 15-271**

1 **WHEREAS, the Tohono O'odham Nation through the Division of Early Childhood**  
2 **Development has been successfully providing services to eligible Tohono**  
3 **O'odham children and families; and**

4 **WHEREAS, the Grants and Contracts Office has identified program savings of \$7,370.12**  
5 **from FY 2014 and FY 2015 Child/Adult Food Program Budget Amendment #1 will**  
6 **increase the total budget to \$92,189.55 from \$87,652.11; and**

7 **WHEREAS, the Indirect Cost Rate is restricted to 15% of total budget therefore, it will be**  
8 **decreased from 20.41% to 15% for FY 2015; and**

9 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
10 **the Legislative Council have reviewed this Budget Amendment #1 and**  
11 **recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the FY 2015 Child/Adult Food Program Budget Amendment #1 to**  
14 **include FY 2014 Savings for an increase in the budget to \$92,189.55.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendments affecting the funds or funding level is**  
18 **submitted for further prior approval by the Tohono O'odham Legislative**  
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
21 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
26 **June 18, 1934 (48 Stat.984).**
