

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment #1 for the Solid Waste Management Program Budget  
001-15-3520 for FY-2015)**

**RESOLUTION NO. 15-272**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the**  
2 **Solid Waste Management Program (SWMP) revenue through Resolution 98-236**  
3 **and 05-558; and**

4 **WHEREAS, the SWMP prepared a budget in the amount of \$1,501,480.84 from general fund**  
5 **and \$410,000.00 from program revenue totaling \$1,911,480.84 overall that was**  
6 **approved by Tohono O'odham Legislative Council for FY-2015; and**

7 **WHEREAS, the SWMP has experienced rising costs for maintenance and repair of**  
8 **equipment, waste disposal fees, fuel and trash bin repairs and replacements**  
9 **due to the increasing demand for services, aging and deteriorating equipment**  
10 **and higher fuel costs; and**

11 **WHEREAS, the SWMP revenue account has sufficient cash flow to cover the \$90,000.00**  
12 **increase from fees for services and the sale of materials for recycling; and**

13 **WHEREAS, the SWMP Budget Amendment #1 has been reviewed by the Legislative**  
14 **Agricultural and Natural Resources and the Legislative Budget and Finance**  
15 **Committees and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
17 **approves Amendment #1 for the Solid Waste Management Program Budget 001-**  
18 **15-3520 for FY-2015 increasing the budget from \$1,911,480.84 to \$2,001,480.84**  
19 **with the additional \$90,000.00 coming from program revenue of the Solid Waste**  
20 **Management Program in accordance with the budget attached hereto.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**  
22 **Chairperson and any designated official to expend and administer the budget as**  
23 **attached, provided that any amendments affecting the funds or funding level is**  
24 **submitted for further prior approval by the Tohono O'odham Legislative**  
25 **Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
27 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
