RESOLUTION NO. 15-273

1 **WHEREAS, Tohono O'odham Legislative Council approved the Executive Branch Fiscal Year**
2 **2015 Tribal Budget on August 11, 2014 by Resolution No. 14-353; and**
3 **WHEREAS, the Environmental Protection Office (EPO) is requesting to increase line item:**
4 **7410 RM Vehicles; and**
5 **WHEREAS, the Environmental Protection Office (EPO) is requesting to add line items: 6245**
6 **Employer PSPRS; 6540 Mileage POV; and**
7 **WHEREAS, the Environmental Protection Office (EPO) is requesting to decrease line items:**
8 **6000 Salaries, 6530 Transportation, 7005 Supplies-Office Equipment; and**
9 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative**
10 **Council has reviewed Budget Amendment #1 and recommends its approval and**
11 **adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves FY 2015 Environmental Protection Office Tribal Budget Amendment #1**
14 **in accordance with the budget attached hereto:**

- 15 1. **To increase line items 7410 RM Vehicles.**
- 16 2. **To add line items 6245 Employer PSPRS; 6540 Mileage POV.**
- 17 3. **To decrease line items 6000 Salaries; 6530 Transportation; 7005 Supplies-**
18 **Office Equipment.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to execute the budget, provided**
21 **however, that any amendments affecting the funds or funding level of the**
22 **budget shall be submitted for further prior approval.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
24 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
29 **June 18, 1934 (48 Stat.984).**
