RESOLUTION NO. 15-274

1 **WHEREAS, the Realty Program is under the Planning and Economic Development**
2 **Department and obtains funding for operations from the BIA 93-638 Master**
3 **Contract; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved the Fiscal Year 2015 Realty**
5 **Program P.L. 93-638 budget under Resolution No. 14-348 at \$29,759.67; and**

6 **WHEREAS, the Nation's Grants and Contracts Office notified the Realty Program of a**
7 **cumulative savings to be added to the FY 2015 Realty Budget; and**

8 **WHEREAS, the Realty Program has prepared budget amendment No. 1 to utilize the**
9 **cumulative savings which will support the daily operations in meeting the**
10 **fulfillment of real estate program standards under the Nation's BIA 638 Master**
11 **Contract; and**

12 **WHEREAS, amendment No. 1 will allow the creating of new line items 6600 Employee**
13 **Tuition Aid, 7355 Professional Service, 7420 RM Building and 7500 Major Capital**
14 **and increasing Operational Expense line items; and**

15 **WHEREAS, also increasing the Indirect Cost and increasing the base budget amount; and**

16 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**
17 **of the Legislative Council have reviewed this budget and recommend its**
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative hereby approves**
20 **Amendment No. 1 to the FY 2015 Bureau of Indian Affairs Realty Program P.L. 93-**
21 **638 Budget to include FY 2014 savings attached hereto:**



9 **Article VI, Section 1(d)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
10 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
11 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
12 **the Act of June 18, 1934 (48 Stat.984).**




