7	WHEREAS,	the National Institutes of Health ("NIH") established the Tribal Consultation
8		Advisory Committee ("TCAC") as an important step towards improving
9		consultation efforts and outreach with tribal partners; and
10	WHEREAS,	the NIH TCAC serves as an advisory body to NIH, helping to ensure that tribes
11		and American Indian/Alaska Native people have meaningful and timely input in
12		the development of relevant NIH policies, programs, and priorities; and
13	WHEREAS,	the NIH TCAC membership includes representation from each of the 12
14		geographic Areas served by the Indian Health Service and five national at-large
15		representatives; and
16	WHEREAS,	the Health and Human Services Committee recommends nominating
17		Representative Chester L. Antone for appointment to the NIH TCAC as the
18		Tucson Area representative and Representative Daniel L.A. Preston, III as
19		alternate to Representative Chester L. Antone.
20	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
21		nominates Representative Chester L. Antone for appointment to the National
22		Institutes of Health Tribal Consultation Advisory Committee as the Tucson Area
23		representative and Representative Daniel L.A. Preston, III as alternate to
24		Representative Chester L. Antone.
