**RESOLUTION NO. 15-277**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**  
2 **protect and provide for public health . . . and general welfare of the Tohono**  
3 **O'odham Nation and its members" and with the authority "to consult with the**  
4 **Congress of the United States and appropriate federal agencies regarding**  
5 **federal activities that affect the Tohono O'odham Nation" (Constitution, Article**  
6 **VI, Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, the American Indian and Alaska Native Health Research Advisory Council**  
8 **("HRAC") supports collaborative approaches between federal and tribal**  
9 **partners to reduce health disparities that affect American Indian and Alaska**  
10 **Native communities; and**

11 **WHEREAS, the HRAC works with tribal leaders to set priorities and make recommendations**  
12 **to U.S. Department of Health and Human Services ("HHS") leadership that**  
13 **inform effective Native health programs and policies; and**

14 **WHEREAS, HRAC is comprised of 16 delegates, who are elected or appointed tribal officials**  
15 **representing each of the 12 Indian Health Service ("IHS") Areas, and four**  
16 **national at-large tribal member positions; and**

17 **WHEREAS, the Health and Human Services Committee recommends nominating**  
18 **Representative Anthony J. Francisco, Jr. for appointment as the HRAC Tucson**  
19 **Area representative and Representative Daniel L.A. Preston, III as alternate to**  
20 **Representative Anthony J. Francisco, Jr.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**  
22 **Representative Anthony J. Francisco, Jr. for appointment as the American**  
23 **Indian and Alaska Native HRAC Tucson Area representative and Representative**  
24 **Daniel L.A. Preston, III as alternate to Representative Anthony J. Francisco, Jr.**

25 **BE IT FURTHER RESOLVED that appointments made pursuant to this resolution shall**  
26 **supersede any prior nominations and appointments to the HRAC and shall**  
27 **immediately expire if the appointed representatives no longer serve on the**  
28 **Health and Human Services Committee for any reason.**
