

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Nominating Representative Daniel L.A. Preston, III as the Indian Health Service  
Tucson Area Tribal Leaders Diabetes Committee Representative and  
Representative Anthony J. Francisco, Jr. as Alternate)**

**RESOLUTION NO. 15-279**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**  
2 **protect and provide for public health . . . and general welfare of the Tohono**  
3 **O'odham Nation and its members" and with the authority "to consult with the**  
4 **Congress of the United States and appropriate federal agencies regarding**  
5 **federal activities that affect the Tohono O'odham Nation" (Constitution, Article**  
6 **VI, Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, the Special Diabetes Program for Indians ("SDPI") was created by Congress to**  
8 **address the disproportionate impact of diabetes in American Indian and Alaska**  
9 **Native communities; and**

10 **WHEREAS, the Tribal Leaders Diabetes Committee ("TLDC") was created by the Indian**  
11 **Health Service ("IHS") Director as an advisory committee in matters related to**  
12 **the SDPI and to make recommendations for the improvement of diabetes care**  
13 **and prevention among American Indian and Alaska Native people; and**

14 **WHEREAS, the TLDC is comprised of one tribal leader and one tribal alternate from each of**  
15 **the 12 IHS Area Offices and are generally tribal elected officials selected by their**  
16 **respective tribe to serve on the TLDC; and**

17 **WHEREAS, since 1997, representatives of the Tohono O'odham Nation have served on the**  
18 **TLDC from the Tucson Area, including most recently Representative Diana**  
19 **Manuel and Representative Racheal Vilson-Stoner as her alternate (Resolution**  
20 **No. 14-044); and**

21 **WHEREAS, Legislative Council Representatives Diana Manuel and Racheal Vilson-Stoner no**  
22 **longer serve on the Health and Human Services Committee; and**

23 **WHEREAS, the Health and Human Services Committee recommends nominating**  
24 **Representative Daniel L.A. Preston, III for appointment as the TLDC Tucson Area**  
25 **representative and Representative Anthony J. Francisco, Jr. as alternate to**  
26 **Representative Daniel L.A. Preston, III.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
28 **nominates Representative Daniel L.A. Preston, III as the Tribal Leaders Diabetes**

3 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that any subsequent  
4 appointments made pursuant to this resolution shall supersede any prior  
5 nominations and appointments to the Tribal Leaders Diabetes Committee and  
6 appointments made pursuant to this resolution shall immediately expire if the  
7 appointed representatives no longer serve on the Health and Human Services  
8 Committee for any reason.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>  
10 day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-  
11 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
12 Article VI, Section 1(c)(2), and (j) of the Constitution of the Tohono O'odham Nation, adopted by  
13 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
15 June 18, 1934 (48 Stat.984).
