

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reaffirming Appointment of Representative Arthur Wilson as Representative to the
Substance Abuse and Mental Health Services Administration Tribal Technical Advisory
Committee and Nominating Representative Anthony J. Francisco, Jr. as Alternate)**

RESOLUTION NO. 15-280

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**
2 **protect and provide for public health . . . and general welfare of the Tohono**
3 **O'odham Nation and its members" and with the authority "to consult with the**
4 **Congress of the United States and appropriate federal agencies regarding**
5 **federal activities that affect the Tohono O'odham Nation" (Constitution, Article**
6 **VI, Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, in 1992 the Congress established the Substance Abuse and Mental Health**
8 **Services Administration ("SAMHSA") as an agency within the U.S. Department of**
9 **Health and Human Services to reduce the impact of substance abuse and mental**
10 **illness on America's communities; and**

11 **WHEREAS, SAMHSA established the SAMHSA Tribal Technical Advisory Committee**
12 **("SAMHSA TTAC") to serve as an advisory body to SAMHSA pursuant to**
13 **Presidential Executive Order No. 13175 and the November 9, 2009 Presidential**
14 **Memorandum; and**

15 **WHEREAS, the SAMHSA TTAC is comprised of 14 elected tribal leaders and designated**
16 **alternates selected by their respective tribes to represent each of the 12 Indian**
17 **Health Service Area Offices and whose terms shall "coincide with each member's**
18 **elected leadership term" (SAMHSA National Advisory Council Charter); and**

19 **WHEREAS, Representative Arthur Wilson currently serves as the Nation's SAMHSA TTAC**
20 **Tucson Area representative and Representative Loretta Lewis serves as**
21 **alternate (Resolution No. 14-049); and**

22 **WHEREAS, Representative Loretta Lewis no longer serves on the Health and Human**
23 **Services Committee; and**

24 **WHEREAS, the Health and Human Services Committee reaffirms the appointment of**
25 **Representative Arthur Wilson as Tucson Area representative on the SAMHSA**
26 **Tribal Technical Advisory Committee and recommends nominating**
27 **Representative Anthony J. Francisco, Jr. to serve as alternate to Representative**
28 **Arthur Wilson.**

1 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
2 **reaffirms the appointment of Representative Arthur Wilson as Tucson Area**
3 **representative on the SAMHSA Tribal Technical Advisory Committee and**
4 **nominates Representative Anthony J. Francisco, Jr. to serve as alternate to**
5 **Representative Arthur Wilson.**

6 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that appointments**
7 **made pursuant to this resolution shall supersede any prior nominations and**
8 **appointments to the SAMHSA Tribal Technical Advisory Committee and shall**
9 **immediately expire if the appointed representatives no longer serve on the**
10 **Health and Human Services Committee for any reason.**


11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
12 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
14 **Article VI, Section 1(c)(2), and (j) of the Constitution of the Tohono O'odham Nation, adopted by**
15 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
17 **June 18, 1934 (48 Stat.984).**




