

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reaffirming Appointment of Representative Arthur Wilson as Primary Representative
to the Indian Health Service National Tribal Advisory Committee on Behavioral
Health and Nominating Representative Anthony J. Francisco, Jr. as Alternate)

RESOLUTION NO. 15-281

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**
2 **protect and provide for public health . . . and general welfare of the Tohono**
3 **O'odham Nation and its members" and with the authority "to consult with the**
4 **Congress of the United States and appropriate federal agencies regarding**
5 **federal activities that affect the Tohono O'odham Nation" (Constitution, Article**
6 **VI, Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, the Indian Health Service established the National Tribal Advisory Committee**
8 **on Behavioral Health ("NTAC") to enhance the government-to-government**
9 **relationship and the Division of Behavioral Health's efforts to improve service**
10 **delivery within Indian Country (NTAC Mission Statement); and**

11 **WHEREAS, the "NTAC helps guide the development of, and support for, behavioral health**
12 **throughout the IHS/Tribal/Urban (ITU) systems, and work to ensure that**
13 **services are as broadly integrated, available and culturally appropriate as**
14 **possible" (National Tribal Advisory Committee on Behavioral Health webpage,**
15 **available at http://www.nihb.org/behavioral_health/ntac_ihs.php); and**

16 **WHEREAS, NTAC's membership consists of 12 elected tribal officials representing each**
17 **Indian Health Service ("IHS") Area with each Area Director selecting two**
18 **members to represent the Area on NTAC, one nominee to serve as the primary**
19 **representative and the other as alternate; and**

20 **WHEREAS, in accordance with the NTAC's Charter, nominees must be elected tribal leaders**
21 **or be selected by tribal leaders; and**

22 **WHEREAS, Representative Arthur Wilson currently serves as the Nation's primary NTAC**
23 **Area representative but does not have an alternate; and**

24 **WHEREAS, the Health and Human Services Committee reaffirms the appointment of**
25 **Representative Arthur Wilson as the primary NTAC Tucson Area representative**
26 **and recommends nominating Representative Anthony J. Francisco, Jr. to serve**
27 **as alternate to Representative Arthur Wilson.**



1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reaffirms**
2 **the appointment of Representative Arthur Wilson as the primary NTAC Area**
3 **representative and nominates Representative Anthony J. Francisco, Jr. as**
4 **alternate to Representative Arthur Wilson.**

5 **BE IT FURTHER RESOLVED that any subsequent appointments made pursuant to this**
6 **resolution shall supersede any prior appointments to NTAC and shall**
7 **immediately expire if the appointed representatives no longer serve on the**
8 **Health and Human Services Committee for any reason.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
10 **day of JULY, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
11 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
12 **Article VI, Section 1(b), Section 1(c)(2), and (j) of the Constitution of the Tohono O'odham**
13 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
14 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
15 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**




