1	WHEREAS,	by Resolution No. 15-127 the Tohono O'odham Legislative Council approved a
2		Plan for the Use of a Portion of the Judgment Funds Awarded in Dockets 345 and
3		102 of the Indian Claims Commission (the "Plan") and authorized the Chairman
4		of the Tohono O'odham Nation (the "Nation") to submit the Plan to the Secretary
5		of the Interior for approval; and
6	WHEREAS,	the Plan provides that amounts, not to exceed \$5.2 million, shall be available for
7		expenditure by the Nation at its request for uses in accord with the provisions of
8		Section III of the Plan; and
9	WHEREAS,	the Investment Committee recommends that the Nation request disbursement
10		of \$5.2 million from the principal portfolio of the account, which is 20 percent of
11		the initial principal amount of \$26 million awarded by the Indian Claims
12		Commission and appropriated by Congress in the Act of September 30, 1976, 90
13		Stat. 1416, and made available to the Nation by section 8(b)(2) of Public Law 97-
14		408 of January 3, 1983, to be expended in accordance with the provisions of
15		Section III of the Plan.
16	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
17		requests that the Department of the Interior Office of the Special Trustee
18		disburse to the Nation \$5.2 million from the principal portfolio of the Indian
19		Claims Commission judgment fund account awarded in Dockets 345 and 102,
20		account number ending in 6215, and requests further that the funds be
21		disbursed to the Nation as soon as possible.
22	BE IT FINALL	Y RESOLVED by the Tohono O'odham Legislative Council that funds disbursed to
23		the Nation pursuant to the Plan shall only be used in accordance with Section III
24		of the Plan.
