**(Approving the Gu Achi District Fiscal Year 2015 Tower User Fees (*1<sup>st</sup> Quarter*)**  
**Budget in the amount of \$30,193.37)**

**RESOLUTION NO. 15-291**

1   **WHEREAS, the Tohono O'odham Legislative Council approved a Management Agreement**  
2                   **between the Tohono O'odham Nation, Gu Achi District and the Tohono O'odham**  
3                   **Utility Authority (*TOUA*) for Jewek Mountain (*Resolution #08-586*) which allowed**  
4                   **the Nation and Gu Achi District to obtain a stream of revenue from TOUA's**  
5                   **leasing space on the transmission tower and the associated equipment building;**  
6                   **and**

7   **WHEREAS, the Management Agreement was revised and approved by the Legislative**  
8                   **Council (*Resolution #14-412*) superseding Resolution #08-586; and**

9   **WHEREAS, on July 25, 2015, the Gu Achi District Council approved Resolution #0715-048 for**  
10                   **a budget in the amount of \$30,193.37 from the revenue of the tower user fees;**  
11                   **and**

12   **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did**  
13                   **review the Fiscal Year 2015 Tower User Fees budget and recommend its**  
14                   **approval.**

15   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16                   **approve the Gu Achi District's Fiscal Year 2015 Tower User Fees (*1<sup>st</sup> Quarter*)**  
17                   **Budget in the amount of 30,193.37 as attached hereto.**

18   **BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby authorizes the**  
19                   **District Chairperson and any designated official to expend and administer the**  
20                   **Budget as attached, provided that any modifications/amendments affecting the**  
21                   **funds or funding level is submitted for further prior approval by the Tohono**  
22                   **O'odham Legislative Council.**

23   **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
24   **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 2,810.40 FOR;**  
25   **-0- AGAINST; -0- NOT VOTING; and 204.9 [04] ABSENT, pursuant to the powers vested in the**  
26   **Council by Article VI, Section 1(h) and (l) of the Constitution of the Tohono O'odham Nation,**  
27   **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
28   **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
29   **16 of the Act of June 18, 1934 (48 Stat.984).**
