1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **counties, through their respective states, to fund equipment purchases and**
3 **training by departments that provide public safety services within their**
4 **respective jurisdictions; and**

5 **WHEREAS, the Tohono O'odham Nation, by Resolution No. 15-064, accepted a grant from**
6 **the Arizona Department of Emergency and Military Affairs, Arizona Division of**
7 **Emergency Management, FFY 2014 Emergency Management Performance Grant**
8 **(EMPG), Grant No. EMW-2014-EP-000016 in the amount of \$25,000 for the Office**
9 **of Emergency Management; and**

10 **WHEREAS, the Subgrantee Agreement No. EMW-2014-EP-000016 provides funding to the**
11 **Nation for costs associated with the workplan developed under the EMPG**
12 **guidelines; and**

13 **WHEREAS, the Subgrantee Agreement has been reviewed by the Domestic Affairs and**
14 **Budget and Finance Committees and recommends its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the Subgrantee Agreement No. EMW-2014-EP-000016 substantially in**
17 **the form attached hereto, and authorizes the Chairman of the Tohono O'odham**
18 **Nation to execute it.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
20 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
21 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 1(f) and 1(l) of the Constitution of the Tohono O'odham Nation, adopted by**
23 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**
