(Approving Amendment No. 1 to Attorney Contract with California Indian Legal
Services for FY2015)**

RESOLUTION NO. 15-297

1 **WHEREAS, by Resolution No. 14-444 the Nation approved an Attorney Contract with**
2 **California Indian Legal Services; and**

3 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**
4 **Contract; and**

5 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**
6 **Attorney General; and**

7 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**
8 **Amendment No. 1 to the Attorney Contract and recommend approval by the**
9 **Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to**
12 **the Attorney Contract with California Indian Legal Services for FY2015**
13 **substantially in the form attached hereto.**
- 14 **2. Funding for Amendment No. 1 shall come from the budget of the Office of**
15 **Attorney General.**
- 16 **3. The Chairperson of the Nation is authorized to execute Amendment No. 1**
17 **to the Attorney Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
19 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**
