RESOLUTION NO. 15-300

1 **WHEREAS, the Tohono O'odham Nation received an Institute of Museum and Library**
2 **Services (IMLS) grant in the amount of \$49,330.00 (Award No. MN-03-12-0017-12)**
3 **for the Tohono O'odham Nation's Himdag Ki: supporting a professional**
4 **development measure through Tohono O'odham Legislative Council**
5 **Resolutions 13-144 and 13-500 for two Museum Trainees as part of the Museum's**
6 **Collections Preparedness Project; and**

7 **WHEREAS, the Tohono O'odham Nation has received an approved no-cost extension from**
8 **the IMLS for the period of Nov. 30, 2014 to Nov. 30, 2015; and**

9 **WHEREAS, the Cultural Center & Museum has prepared a FY 2016 budget to expend the**
10 **remaining funds of the award, currently budgeted at \$18,748.25; and**

11 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees of the**
12 **Legislative Council have reviewed this Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **approves the FY 2016 IMLS Native American / Native Hawaiian Museum Service**
15 **Award No. MN-03-12-0017-12 budget in the amount of \$18,748.25 for the last two**
16 **months of the grant period of Nov. 30, 2014 to Nov. 30, 2015.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding levels is**
20 **submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
23 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
