

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of the FY15 Title IV-B Subpart 1 & 2 awards from U.S. Department  
of Health and Human Services Administration for Children and Families and  
approving the FY 2015 Amendment #1 for Title IV-B Subpart 1 & 2 Budgets)**

**RESOLUTION NO. 15-302**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**  
2 **the Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated the Division of Child Welfare Services**  
4 **to intervene against child abuse and neglect and to promote safe and stable**  
5 **families; and**

6 **WHEREAS, the Title IV-B, Subpart 1 grant requires a 25% match, which the Tohono O'odham**  
7 **Nation matches through the P.L. 93-638 master contract, specifically the BIA**  
8 **Social Services budget for child welfare services and the BIA budget for Family**  
9 **Preservation Program; and**

10 **WHEREAS, Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two year expenditure**  
11 **period, beginning October 1, 2014 and ending September 30, 2016, funding only**  
12 **the two fiscal years of FY 2015 and FY 2016; and**

13 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children**  
14 **and Families (ACF), has notified the Nation that The Child and Family Services**  
15 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to**  
16 **10% starting October 1, 2007 for Title IV-B budgets, and the Department**  
17 **requests approval to submit these budgets with the restricted 10% amount for**  
18 **indirect costs; and**

19 **WHEREAS, the Title IV-B subpart 1 & 2 Budgets were approved by Tohono O'odham**  
20 **Legislative Council Resolution #14-356; and**

21 **WHEREAS, the Nation received notification the award for Title IV-B Subpart 1 in the amount**  
22 **\$132,822.00 and for Title IV-B Subpart 2 in the amount of \$204,430.00; and**

23 **WHEREAS, the Department of Health and Human Services has prepared the attached FY**  
24 **2015 Title IV-B Subpart 1 & 2 Amendment #1 Budgets changing the base budget**  
25 **amount and increasing the IDC amount; and**

26 **WHEREAS, the Title IV-B Subpart 1 Budget Amendment #1 will allow the creating of line**  
27 **item 7010 Program Supplies, 7340 Public Relations and 7355 professional**  
28 **services and increasing Operational Expense line items; and**

29 **WHEREAS, the Title IV-B Subpart 2 Budget Amendment #1 allows the creating of line item**  
30 **7000 Supplies Office and 7010 Program Supplies and increasing Operational**  
31 **Expense line items; and**

**WHEREAS, the Health and Human Service Oversight and the Budget and Finance Committees has reviewed this budget and recommend its approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**

- 1. Accepts and approves the Title IV-B Subpart 1 and Title IV-B Subpart 2 from the U.S. Department of Health & Human Services Administration for Children and Families, effective October 1, 2014 and ending September 30, 2016 and authorizes expenditure of funds.**
- 2. Approves the FY 2015 Department of Health and Human Services Title IV-B, Subpart 1 & 2 Amendment #1 Budgets to reflect the restricted 10% indirect cost rate.**
- 3. Authorizes the Child Welfare Program to utilize the Nation's resources pending reimbursement from the Grantor for the continuation of the Grant.**

**BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Chairperson and any designated official to expend and administer the budget, as attached, provided that any amendments affecting the funds or funding level shall be submitted for further prior approval by the Tohono O'odham Legislative Council.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.30 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


