7	WHEREAS,	Amendment No. 1 to the Intergovernmental Agreement (IGA-YH13-0004-007) will
8		extend the term of the Agreement for a three (3) year period effective October 1,
9		2015 through September 30, 2018 to allow Tohono O'odham Nation to continue
10		long term care case management services that the ALTCS Program currently
11		provides; and
12	WHEREAS,	there were no <u>substantial content</u> changes to the language contained within the
13		IGA; the processes/expectation related to Case Management remain the same;
14		and
15	WHEREAS,	all reimbursement ALTCS Program client compensated funds shall be applied to
16		the ALTCS operational budget (600-6200) for program operations; and
17	WHEREAS,	the Health and Human Services and the Budget and Finance Committees of the
18		Legislative Council have reviewed the Intergovernmental Agreement
19		Amendment No. 1 and recommend its approval.
20	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
21		approves Amendment No. 1 to the Intergovernmental Agreement (IGA-YH13-
