

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2015 Arizona Long Term Care Systems Budget Amendment #1)**

**RESOLUTION NO. 15-305**

1 **WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State**  
2 **of Arizona (AHCCCS) to provide Arizona Long Term Care Systems (ALTCS) Case**  
3 **Management services to eligible enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has provided ALTCS case management services**  
5 **since June 1996 and is compensated from the State of Arizona for the services;**  
6 **and**

7 **WHEREAS, FY2015 Budget Amendment #1 was prepared to adjust line items per the**  
8 **attached budget and add line item 7420 - Repair & Maintenance Building; and**

9 **WHEREAS, all reimbursement ALTCS Program client compensated funds shall be applied to**  
10 **the ALTCS operational budget for program operations; and**

11 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
12 **Legislative Council have reviewed the Budget Amendment #1 and recommend**  
13 **its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
15 **approves the FY2015 Budget Amendment #1 adjusting line items and adding line**  
16 **item 7420 - Repair & Maintenance Building line item to meet the needs of the**  
17 **program for the duration of the fiscal year.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson to expend and administer the budget as attached, provided that**  
20 **any amendments affecting the funds or funding level is submitted for further**  
21 **prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
23 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR;**  
24 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation,**  
26 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
28 **16 of the Act of June 18, 1934 (48 Stat.984).**


