

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the Establishment of Indigenous Peoples' Day in Tucson and Other Jurisdictions)

RESOLUTION NO. 15-316

1 **WHEREAS, the Tohono O'odham Legislative Council ("Council") of the Tohono O'odham**
2 **Nation recognizes that the Indigenous Peoples of the lands that would later**
3 **become known as the Americas have lived in these lands since time**
4 **immemorial; and**

5 **WHEREAS, the Legislative Council recognizes that the City of Tucson ("City") was founded**
6 **upon the homelands and villages of the Indigenous Peoples of this region,**
7 **without whom the building of the City would not have been possible; and**

8 **WHEREAS, the Legislative Council values the progress of our society that would not have**
9 **been possible without Indigenous Peoples' knowledge, thought, technology,**
10 **agriculture, science, philosophy, arts and deep spiritual and cultural**
11 **contributions that have substantially shaped the character of the City of Tucson;**
12 **and**

13 **WHEREAS, Indigenous Peoples' Day was proposed in 1997 by a delegation of Native nations**
14 **to the United Nations-sponsored International Conference on Discrimination**
15 **Against Indigenous Populations in the Americas; and**

16 **WHEREAS, in 1990 representatives from 120 Indigenous nations at the First Continental**
17 **Conference on 500 Years of Indian Resistance unanimously passed a resolution**
18 **to transform Columbus Day into a day to promote continental unity and the**
19 **struggle toward liberation, and thereby reveal a more accurate historical**
20 **reality; and**

21 **WHEREAS, while the Tohono O'odham Nation does not recognize Columbus Day as a tribal**
22 **holiday, the United States government, the State of Arizona, and the City of**
23 **Tucson recognize Columbus Day on the second Monday of October in**
24 **accordance with the federal holiday established in 1937; and**

25 **WHEREAS, the Cultural Preservation Committee reviewed the Indigenous Peoples' Day**
26 **proposal and recommends that the Legislative Council support it.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports**
28 **efforts to have the City of Tucson Council and other jurisdictions recognize the**

1 second day of Monday in October as Indigenous Peoples' Day instead of
2 recognizing it as Columbus Day.

3 **BE IT FURTHER RESOLVED that the Indigenous Peoples' Day shall be used to reflect upon the**
4 **ongoing struggles of Indigenous people on this land and to celebrate the**
5 **thriving culture and value that all Indigenous nations add to our city, county,**
6 **and state; these nations are: Tohono O'odham Nation, Pascua Yaqui Tribe, Hopi**
7 **Tribe, Yavapai-Prescott Indian Tribe, Kiabab-Paiute Tribe, Zuni Pueblo,**
8 **Cocopah Indian Tribe, Colorado River Indian Tribes, Hualapai Tribe, Havasupai**
9 **Tribe, San Juan Southern Paiute Tribe, Yavapai-Apache Nation, Fort McDowell**
10 **Yavapai Nation, Fort Yuma-Quechan Tribe, Gila River Indian Community, Salt**
11 **River Pima-Maricopa Indian Community, Tonto Apache Tribe, White Mountain**
12 **Apache Tribe, Ak-Chin Indian Community, Fort Mojave Indian Tribe, Navajo**
13 **Nation and the San Carlos Apache Tribe.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council calls upon the City of**
15 **Tucson to:**

- 16 1. **Promote the well-being and growth of Native American and Indigenous**
17 **communities.**
- 18 2. **Formally recognize Indigenous Peoples' Day as an opportunity to**
19 **celebrate the thriving cultures and values of the Indigenous Peoples of**
20 **our region.**
- 21 3. **Strongly encourage all Tucson-area schools to teach Indigenous peoples'**
22 **history as part of the regular curriculum.**
- 23 4. **Encourage businesses, other organizations, and public institutions to**
24 **recognize Indigenous Peoples' Day when it is established.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
26 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(c)(8) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**
