

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Arizona Department of Economic Security Planned Social
Services Title XX Block Grant Budget)**

RESOLUTION NO. 15-317

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through funding provided by the Arizona**
3 **Department of Economic Security's (A.D.E.S) Planned Social Services Block**
4 **Grant (S.S.B.G.) Title XX Program; and**

5 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its**
6 **young members by providing for their welfare through various programs and**
7 **services designed to meet their special needs; and**

8 **WHEREAS, the Arizona Department of Economic Security has negotiated a cost-**
9 **reimbursement Intergovernmental Agreement, for a five year term from FY 2013**
10 **to 2018 with the Tohono O'odham Nation for an Arizona Department of**
11 **Economic Security Planned Social Services Title XX Block Grant in which the**
12 **Nation will receive full reimbursement for all Title XX expenses; and**

13 **WHEREAS, the Arizona Department of Economic Security Planned Social Services Title XX**
14 **Block Grant Budget for FY2016 has been created in the amount of \$99,612.00;**
15 **and**

16 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
17 **the Legislative Council have reviewed this Budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
19 **approve and authorize the Arizona Department of Economic Security Planned**
20 **Social Services Title XX Block Grant Budget for Fiscal Year 2016 in the amount of**
21 **\$99,612.00 and to utilize the Nation's Resources pending reimbursement from**
22 **the Grantor for the continuation of the Grant.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the Budget as**
25 **attached, provided that any Amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative**
27 **Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
