

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY15 Child Care & Development Fund-Mandatory Budget Amendment #1)**

RESOLUTION NO. 15-318

1 **WHEREAS, the Department of Health and Human Services, Administration for Children and**
2 **Families has awarded the Tohono O'odham Nation the Child Care &**
3 **Development Fund for Grant Year 2015 to implement Child Care Services**
4 **through the Division of Early Childhood Development; and**

5 **WHEREAS, the FY 2015 Notice of Grant Award reflects a decrease in the Child Care &**
6 **Development Fund - Mandatory Allotment to \$413,462.00; and**

7 **WHEREAS, this amendment #1 will allow the decrease to the Personnel line items due to a**
8 **change in salary split cost share and reduce all operational line items per the**
9 **attached budget; and**

10 **WHEREAS, the indirect cost rate is capped at 15%; and**

11 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
12 **the Legislative Council have reviewed this Budget Amendment #1 and**
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the FY15 Child Care & Development Fund-Mandatory Budget**
16 **Amendment #1 to decrease the budget from \$663,936.00 to \$413,462.00 and**
17 **capping the indirect cost rate at 15%.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funding level is**
21 **submitted for further prior approval by the Tohono O'odham Legislative**
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
24 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2)(3)and1(f) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
29 **the Act of June 18, 1934 (48 Stat.984).**
