

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2015 ECHS Grant Administration Budget Amendment #1)**

RESOLUTION NO. 15-319

1 **WHEREAS, the Tohono O'odham Nation through the Head Start Program has been**
2 **successfully providing services to eligible Tohono O'odham children and**
3 **families; and**

4 **WHEREAS, this amendment #1 will utilize savings from vacancies from the following**
5 **positions: Maintenance Technician and Receptionist at 66.67%/33.33% in the**
6 **amount of \$24,678.34; and**

7 **WHEREAS, increasing the cost share for the Accounting Specialist and Receptionist to 100%**
8 **from 50% thus increasing Personnel Costs; and**

9 **WHEREAS, the Indirect Cost has been decreased from \$72,301.60 to \$53,742.49, not**
10 **exceeding the 15% Administrative Costs and adjusting Operational line items**
11 **per the attached budget; and**

12 **WHEREAS, line items have been increased: 7000 Supplies – Office \$2,999.01, 7100 Utilities**
13 **\$8,710.85; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees of the**
15 **Legislative Council have reviewed this Budget Amendment #1 and recommend**
16 **its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
18 **approved the FY 2015 Early Childhood Head Start Grant Administration Budget**
19 **Amendment #1 with changes to the salary split for the Accounting Specialist and**
20 **Receptionist from 50/50 to 100% and salary savings for both Maintenance**
21 **Technician and Receptionist at 66.67%/33.33%. The Administrative Cost should**
22 **not exceed 15% of the Budget at \$317,057.00.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative**
27 **Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


