

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY15 Child Care & Development Fund-Discretionary Budget Amendment #1)**

**RESOLUTION NO. 15-320**

1 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
2 **Families has awarded the Tohono O'odham Nation the Child Care &**  
3 **Development Fund for Grant Year 2015 to implement Child Care Services**  
4 **through the Division of Early Childhood Development; and**

5 **WHEREAS, the FY2015 Notice of Grant Award reflects a decrease in the Child Care &**  
6 **Development Fund – Discretionary Allotment to \$284,323.00; and**

7 **WHEREAS, budget Amendment #1 adjusts personnel costs due to a change in Salary splits**  
8 **and decreased all operational line items per the attached budget; and**

9 **WHEREAS, the indirect cost rate is capped at 15%; and**

10 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
11 **the Tohono O'odham Legislative Council have reviewed this Budget Amendment**  
12 **#1 and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **approves the FY15 Child Care & Development Fund-Discretionary Budget**  
15 **Amendment #1 to decrease from \$373,338.00 to \$284,323.00 and capping the**  
16 **indirect cost at 15%.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
18 **Chairperson and any designated official to expend and administer the budget as**  
19 **attached, provided that any amendments affecting the funds or funding level is**  
20 **submitted for further prior approval by the Tohono O'odham Legislative**  
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
23 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**  
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
28 **the Act of June 18, 1934 (48 Stat.984).**
