7	WHEREAS,	by Resolution No. 14-421, the Tohono O'odham Legislative Council approved the
8		FY 2014 Magdalena Visitor Center Project Budget to fund the Magdalena Visitor
9		Center for 2014; and
10	WHEREAS,	the Legislative Branch will again operate the Magdalena Visitor Center for 2015
11		with volunteers and occasional appointments for the upcoming pilgrimage, and
12		accordingly has drafted the Legislative Branch FY 2015-FY 2016 Magdalena
13		Visitor Center Project Budget, which is incorporated by this reference; and
14	WHEREAS,	the Cultural Preservation and the Budget and Finance Committees have
15		reviewed the Legislative Branch FY 2015-FY 2016 Magdalena Visitor Center
16		Project Budget and recommend its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
18		and authorizes expenditure of the Legislative Branch FY 2015-FY 2016
19		Magdalena Visitor Center Project Budget in the amount of \$11,500.00, as per the
20		attached budget, beginning August 8, 2015 and ending September 30, 2016,
21		which shall be funded by the Nation's FY 2015 general fund surplus.

24		administer the Budget as attached, provided that any amendments affecting the
