

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting August 18, 2015 Special Session for United States Customs and Border  
Protection Presentation and Issues)**

**LEGISLATIVE ORDER NO. 15-327**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6 **Council with the authority to "by majority vote, call for a special session."**  
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8 **1.D.1.); and**

9 **WHEREAS, the Domestic Affairs Committee has requested an August 18, 2015 special**  
10 **session for United States Customs and Border Protection presentation and**  
11 **issues.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets an**  
13 **August 18, 2015 special session for United States Customs and Border Protection**  
14 **presentation and issues.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> day of**  
16 **AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,015.3 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
18 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
21 **June 18, 1934 (48 Stat.984).**
