Distribution in the amount of \$126,260.07)

RESOLUTION NO. 15-333

1 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution #15-275 for**
2 ***“Implementing Initiative No. INT-01-14, “Dissolution of the Hia Ced District and***
3 ***Distributing Funds to Nation’s Districts”*for an equal distribution to the Nation’s**
4 **eleven Districts for an amount of \$126,260.07; and**

5 **WHEREAS, on August 7, 2015, the Gu Achi District Council approved Resolution #0815-060**
6 **for a budget in the amount of \$126,260.07 from Initiative INT-01-14 Distribution;**
7 **and**

8 **WHEREAS, the Tohono O'odham Legislative Council’s Budget and Finance Committee did**
9 **review the budget and recommend its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the Gu Achi District Fiscal Year 2015 Budget from Initiative INT-01-14**
12 **Distribution in the amount of \$126,260.07 as attached hereto.**

13 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
14 **District Chairperson and any designated official to expend and administer the**
15 **Budget as attached, provided that any modifications/amendments affecting the**
16 **funds or funding level is submitted for further prior approval by the Tohono**
17 **O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
19 **day of AUGUST, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
20 **-0-AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**
