| 10 |            | procedures" and supplements "government-to-government consultation by            |
| 11 |            | coordinating with and obtaining input from tribes, BIA, and FHWA" (25 C.F.R.     |
| 12 |            | §170.155(a)); and  |
| 13 | WHEREAS,   | the Coordinating Committee consists of 12 tribal regional representatives (one   |
| 14 |            | from each BIA Region), with one alternate tribal member for each regional        |
| 15 |            | representative, provided that each "tribal representative must be a tribal       |
| 16 |            | governmental official or employee with authority to act for the tribal           |
| 17 |            | government" (25 C.F.R. §170.155(b) and (c)); and                                 |
| 18 | WHEREAS,   | Representative Billman Lopez, who is Chairman of the Legislative Agricultural    |
| 19 |            | and Natural Resources Committee, which has oversight of the Nation's roads,      |
| 20 |            | land and natural resources issues, is qualified to serve on the TTP Coordinating |
| 21 |            | Committee; and   |
| 22 | WHEREAS,   | it is in the Nation's best interest to nominate Representative Billman Lopez to  |
| 23 |            | serve on the TTP Coordinating Committee.   |
| 24 | NOW, THERE | FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it:          |
| 25 |            | (1) nominates Representative Billman Lopez, who is an elected tribal             |
| 26 |            | governmental official authorized by this resolution to serve as the TTP          |
| 27 |            | Coordinating Committee Western Region tribal representative; provided            |
| 28 |            | that if Representative Lopez is appointed, he shall provide quarterly            |
