

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 15-289, "Approving New Enrollment Numbers for the
Newly Enrolled Members of the Hia-Ced District in Accordance with Initiative
INT-01-14, 'Dissolution of the Hia Ced District,'" to correct the Enrollment
Numbers)**

RESOLUTION NO. 15-344

1 **WHEREAS, Article IX, Section 2 of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to create additional**
3 **districts; and**

4 **WHEREAS, effective October 30, 2012, the Legislative Council created the Hia-Ced District by**
5 **Resolution No. 12-423 and the creation of the Hia-Ced District of the Tohono**
6 **O'odham Nation ordinance, 27 Tohono O'odham Code Chapter 1; and**

7 **WHEREAS, Section 1105(B) of the creation of the Hia-Ced District ordinance provides that:**
8 **"O'odham who are not enrolled members of the Tohono O'odham Nation but**
9 **who apply for enrollment may request the Hia-Ced District as their regional**
10 **reference (district designation)"; and**

11 **WHEREAS, the Legislative Council approved membership applications for 14 members who**
12 **requested the Hia-Ced District as their regional reference in part by Resolution**
13 **Nos. 13-391, 14-026, 14-081 and 14-105; and**

14 **WHEREAS, on April 25, 2015, the Hia-Ced District was dissolved by the Tohono O'odham**
15 **Nation's voters through Initiative INT-01-14, Dissolution of the Hia-Ced District;**
16 **and**

17 **WHEREAS, the Dissolution of the Hia-Ced District Initiative provides, in relevant part, that**
18 **"[n]ew Hia Ced District members to select parents Regional reference;" and**

19 **WHEREAS, the 14 members were given new enrollment numbers with their parent(s)**
20 **original regional reference in accordance with the Dissolution of the Hia-Ced**
21 **District Initiative pursuant to Resolution No. 15-289; and**

22 **WHEREAS, the 14 members were incorrectly given "15" for the year portion of the**
23 **enrollment number when the year portion should reflect the year that each**
24 **member submitted the membership application; and**

25 **WHEREAS, the Enrollment Program, therefore, recommends that Resolution No. 15-289 be**
26 **amended to correct the year portion of the enrollment number for the members**
27 **identified in the Amending Resolution No. 15-289 Summary, which is**
28 **incorporated by this reference.**



8 **day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4**

10 **Council by Article VI, Section 1(h) and (l) of the Constitution of the Tohono O'odham Nation,**
11 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
12 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
13 **16 of the Act of June 18, 1934 (48 Stat.984).**
